### **1. APPROVAL OF CONSENT**

### **3. PURPOSE AND LEGAL BASIS OF THE PROCESSING OF PERSONAL DATA**

Personal data are processed (i) to assess the data subject's request to establish cooperation with the Administrator on the purchase and sale of shading technology, (ii) to provide the information on the Administrator's products by the Administrator to the data subject (information on the Administrator's products, especially technical data, drawings or photographs) and (iii) in the event of a contractual relationship, personal data are processed to fulfill the rights and obligations arising therefrom. Personal data are also processed for marketing activities - newsletters, offers, etc.

Personal data are processed (i) on the basis of this consent, (ii) due to the implementation of the precautionary measures prior to the conclusion of a contract establishing a contractual relationship between the data subject and the Administrator, and (iii) due to the performance of this contractual relationship.

### **4. SCOPE OF THE PROCESSING OF PERSONAL DATA**

The personal data of data subjects are processed to the extent of:

- a) first name and surname;
- b) main office address;
- c) email;
- d) phone number.

## **5. TIME PERIOD OF THE PROCESSING OF PERSONAL DATA**

The time period of the processing of personal data is ten years from the date of consent. In the event of the conclusion of a contractual relationship between the data subject and the Administrator, the time period of the processing of personal data is for at least such time as is strictly necessary to ensure the rights and obligations arising from this contractual relationship.

## **6. INFORMATION ON POTENTIAL RECIPIENTS AND INTENTION OF PASSING ON INFORMATION**

The Administrator does not provide the personal data provided by the data subject to any natural or legal person, public authority or other entity and does not provide them to any third party either.

The Administrator does not intend to pass on the personal data of the data subject to a third country or an international organization.

## **7. ADDITIONAL INFORMATION ON THE PROCESSING OF PERSONAL DATA**

The data subject acknowledges that it has the right to withdraw the consent at any time, request the Administrator to provide the information about the scope of the data processed by the Administrator, request access to these data and update or correct these data, and the right to request the deletion of such personal data. Furthermore, the data subject is entitled to object to the processing of personal data. In the event of any doubt as to the fulfillment of the obligations related to the processing of personal data, the data subject is entitled to contact the Administrator or the supervisory authority, namely the Office for Personal Data Protection. The data subject declares to have been sufficiently aware of its rights regarding the processing of personal data, that the above personal data are accurate and true, and that they are provided to the Administrator on a voluntary basis.
