

## Sales promotion rules

### LIGHTING OF YOUR CHOICE FOR THE LAMELINO BIOCLIMATIC PERGOLA FOR ONLY 1 EUR

The purpose of this document is to provide a complete and clear set of rules for the sales promotion of SERVIS CLIMAX a. s. "LIGHTING FOR LAMELINO FOR 1 CZK" (hereinafter referred to as the "sales promotion"). These rules may only be amended in the form of written addenda to this document.

#### 1. Organizer of the sales promotion:

The organizer of the sales promotion is SERVIS CLIMAX a. s., with its registered office at Jasenice 1253, 755 01 Vsetín,

ID No.: 25352628, VAT ID: CZ25352628, registered in the Commercial Register maintained by the Regional Court in Ostrava under file number B 3231 (hereinafter referred to as the "organizer").

#### 2. Date and place of the sales event:

The sales event will take place from 1 February 2026 at 00:00 to 28 February 2025 at 23:59 (hereinafter referred to as the "sales event period") in the Czech Republic (hereinafter referred to as the "sales event venue"). The promotion applies only to pergola orders manufactured and delivered by CLIMAX to a partner installation company by April 30, 2026.

#### 3. Sales event participant:

Only natural persons over the age of 18 may participate in the sales event (hereinafter referred to as the "sales event participant").

#### 4. Products included in the sales event:

Customers who purchase a LAMELINO bioclimatic pergola are entitled to receive lighting of their choice with their order, i.e. either slat lighting or perimeter lighting for the pergola for CZK 1.

Participants are required to provide the organizer with the necessary cooperation to verify compliance with these rules.

#### 5. Conditions for participation in the sales promotion:

5.1. Placing a binding order for a LAMELINO bioclimatic pergola, which is part of this sales promotion, with CLIMAX brand shading retailers.

5.2. The binding order must be placed between February 01, 2026, and February 28, 2026.

5.3. Complete and correctly fill in the online registration form on the website [www.climax.cz](http://www.climax.cz), send it, and report the unique code to the dealer, who will include this code in the binding order. By ticking the consent box when submitting the registration form, the participant agrees to receive commercial communications from the seller to the email address provided by the contestant in accordance with Section 7(2) of Act No. 480/2004 Coll. on certain information society services. Consent to the sending of commercial communications and offers may be revoked at any time, electronically, by sending a revocation of consent to [climax@climax.cz](mailto:climax@climax.cz).

The customer is responsible for the accuracy and completeness of the information provided. In particular, registrations made outside the duration of the sales event or registrations that do not contain all the correct information, do not meet the specified format, or otherwise do not meet the conditions of the sales event will not be included in the sales event. The organizer of the sales event reserves the right to make the final assessment of registrations. 5.4. The promotion applies only to pergola orders manufactured and delivered by CLIMAX to a partner installation company by April 30, 2026.

## 7. Final provisions:

The organizer is not liable for any direct or indirect damage in connection with participation in the sales event. Persons who do not meet the conditions for participation in the sales event or who act in violation of the rules will not be included in the sales event. The organizer reserves the right to exclude a participant in the sales event whose behavior shows signs of unfair or fraudulent conduct without giving a reason. The organizer of the sales event is not liable for any technical problems in

connection with participation in the sales event. The organizer reserves the right to shorten, interrupt, or cancel the sales event or change its rules for serious reasons.

In the event of changes to the terms and conditions of the sales event, these will be made in writing in the form of an addendum and published at [www.climax.cz](http://www.climax.cz). This change shall take effect at the time of publication in accordance with the previous sentence. The organizer of the sales promotion reserves the right to make the final assessment of whether the conditions for obtaining a bonus in the sales promotion have been met or not.
